# **Commercial Leasing Masterclass**

A commercial lease is one of the most common **and** onerous contracts that can be entered into under Scots Law. Accordingly, mastering the drafting process and an understanding of the respective liabilities and obligations arising from such contracts is crucial for fee earners working in the commercial property field.

This detailed session will provide a thorough analysis of the common issues and technical black letter law detail, to ensure all participants emerge with a better, practical understanding of how to maximise efficiency and minimise risk when dealing with commercial leases.

The aims of this Leasing Masterclass are threefold -

- → Identify the liability of a Landlord at common law (and to allow the attendee to understand why many of the clauses in the Lease are necessary from the Landlord's perspective), inclusive of the position on "extraordinary repairs";
- → Understand and Identify the "hidden" obligations of a Tenant under its duty to comply with statute in a commercial Lease eg Control of Asbestos Regulations 2012, Fire (Scotland) Act 2005, Climate Change (Scotland) Act 2009, Gas / Electrical Appliance Certification in the property, the Planning (Scotland) Act 1997 and Building (Scotland) Act 2003; the Environmental Protection Act 1990 etc; and
- → Identify various standard clauses in the Lease and see what revisals can be proposed from the Tenant's perspective in order to restrict its liability.
